#### **Course Approval**

The syllabus was approved by the Faculty of Health, Science and Technology 2023-03-07, and is valid from the Autumn semester 2023 at Karlstad University.

# **Prerequisites**

Registered for 180 ECTS credits in the Master of Science programme in energy and environmental engineering, chemical engineering, or industrial management, plus Sustainable Development, 7.5 ECTS credits, Environmental Technology, 7.5 ECTS credits, and Thermal Fluid Sciences, 7.5 ECTS credits, plus upper secondary level Swedish 3 or Swedish as a second language 3 and English 6, or equivalent

#### **Learning Outcomes**

The aim of the course is for students to acquire in-depth knowledge of the structure of biomass, bioenergy, and existing and emergent forest industry processes.

Upon completion of the course students should be able to:

- explain the concept of bioeconomy and give an account of different perspectives on the forest as a resource,
- give an account of sustainability aspects of industrial processes for biomass,
- give an account of the structure of wood in terms of its macro-molecular components,
- explain and give examples of bioindustrial processes, and
- give an account of and explain selected unit operations within the area of bioindustrial processes.

#### Content

The course comprises the following components:

- The concepts of bioeconomy and circularity
- The forest as a resource and biological diversity
- Policy instruments in bioeconomy
- Forestry and harvesting techniques
- Resource management in industrial processes
- The development of biomass from the perspective of evolution
- Wood and fibre morphology
- The chemical structure of biomass
- The environmental impact of forest industry processes

The course provides knowledge of the following processes:

- Sawmilling
- Wooden construction
- Mechanical and chemical pulp production
- Paper production technology
- Solid biofuels
- Drying technology
- Biorefineries
- New materials and processes
- Selected unit operations in bioindustrial processes, such as for instance drying, pelleting, and extrusion.

The final part of the course is a project in which students engage in in-depth study of a research question related to the concept of bioeconomy.

#### **Examination**

Assessment is based on:

- Active participation in seminars (1.5 ECTS cr)
- An individual written exam (10.5 ECTS cr)
- Written and oral project presentations (3 ECTS cr)

#### **Grades**
