# **Course Approval**

# Prerequisites

90 ECTS credits completed, including a degree project of 15 ECTS credits at the G2F level in English or another main field of study in the humanities or social sciences, and upper secondary level English 6, or equivalent

#### **Learning Outcomes**

Upon completion of the course, students should be able to:

1. give an account of and critically assess theoretical approaches and methods in the field of language and gender,

2. give an account of and critically assess how the concepts of sex and gender are understood and operationalised in various linguistic approaches, and

3. apply selected research approaches in independent analysis of oral or written language data.

# Content

The course treats current and earlier linguistic approaches to the interface between language and gender. The course covers theoretical and methodological perspectives in relation to research on both oral and written language data, with a special emphasis on how language can be gendered and how gender is performed and expressed in language use in various contexts such as everyday conversations, journalism, social media, at work and in school. The course treats methods and perspectives from for example sociolinguistics, critical discourse analysis, and conversation analysis, with an emphasis on qualitative research methods.The course highlights how linguistic approaches can contribute to further study of important issues in feminist theory, queer theory, masculinity studies, and so forth.
