Learning Outcomes

Upon completion of the course, students should be able to:

- 1. analyse and interpret contemporary Spanish literature in different genres, using basic theoretical concepts,
- 2. independently analyse texts with a focus on their historical, cultural and literary context,
- 3. search for, assess and structure information and present it orally and in writing with correct handling of sources, quotations and references according to instructions and
- 4. produce well structured and coherent texts.

Content and Form of Instruction

The course includes reading, analysing and interpreting 20th and 21st century literary texts in different genres. Basic theoretical concepts are applied in the analysis and interpretation of the texts and contribute to developing students' understanding of literary perspectives and interpretation strategies.

Examination

Assessment is individual.

Learning outcome 1-3 are assessed on the basis of mandatory seminar discussions. All learning outcomes are also assessed on the basis of written hand-in assignments.

Grades

One of the grades Distinction (VG), Pass (G), or Fail (U) is awarded in the examination of the course.

Quality Assurance

Follow-up relating to learning conditions and goal-fulfilment takes place both during and upon completion of the course in order to ensure continuous improvement. Course assessment is based on student views and experiences as reported in written course evaluations and/or group discussions. Students will be informed of the result of the evaluation and of the measures to be taken.

Course Certificate

A course certificate will be provided upon request.

Additional Information

Students who enrolled before 1 July 2007 will complete their studies in accordance with the requirements of the earlier admission. Upon completion students may request degree and course certificates to be issued under the current ordinance if they meet its requirements.

The course ESGB40 cannot be included in the same degree programme as the courses ESGB01, ESGBB3 and ESGBLA.
