Language of Instruction

The language of instruction is Swedish. Some components can be taught in English for the benefit of non-Swedish-speaking students. Individual supervision is offered in Swedish and English

Upper secondary level English B or equivalent. Business Administration 90 ECTS cr, including Degree Project 15 ECTS cr, and the course FEAD22 Advanced Professional Skills 15 ECTS cr

Learning Outcomes

Upon completion of the course, students should be able to:

- -independently identify and examine a problem in the field of business administration,
- -critically evaluate research methods,
- -relate problems in the field of business administration to research methods
- search for, critically evaluate and use relevant theory for the chosen problem area,
- reflect on the relation beween theory and empirical data,
- describe and analyse empirical data,
- -present their research process and results clearly and concisely in oral and written form,
- -critically review the work presented by other students.

Content and Form of Instruction

The degree project entails planning and completing relevant investigations in a business administration area, analysing the data and presenting conclusions. Students are expected to participate in seminars and supervision sessions and to defend their thesis at a final seminar. They are also required to critically review and discuss other students' work. Supervision is only offered to students while the course is in progress. Students who fail to complete the project satisfactorily during this time may re-register at the next course opportunity. They will then be offered additional supervision to the extent made possible by available resources.

Examination

Assessment is based on the submitted thesis and active seminar performance. The number of examination opportunities is limited to five.

Grades

One of the grades Distinction (VG), Pass (G), or Fail (U) is awarded in the examination of the course.

Quality Assurance

Follow-up relating to learning conditions and goal-fulfilment takes place both during and upon completion of the course in order to ensure continuous improvement. Course assessment is based on student views and experiences as reported in written course evaluations and/or group discussions. Students will be informed of the result of the evaluation and of the measures to be taken.

Course Certificate

A course certificate will be provided upon request.

Additional Information

Students who enrolled before 1 July 2007 will complete their studies in accordance with the requirements of the earlier admission. Upon completion students may request degree and course certificates to be issued under the current ordinance if they meet its requirements.
