FEGA01 Business Administration I, 30 ECTS credits, and FEGB01 Business Administration II, 30 ECTS credits, or equivalent

# Learning Outcomes

Upon completion of the course, students should be able to:

1. give an account of common instruments used for management control,

2. identify and reflect upon factors that have an impact on the design and use of management control,

3. give an account of and critically reflect upon traditional management control and alternative perspectives on management control,

4. explain theoretical concepts and models in the area and discuss them critically,

5. critically analyse and discuss complex phenomena, issues, and situations in management control,

6. search for, summarise, and assess research on management control, and

7. produce a scientific report in the area of management control, within given time limits and in accordance with instructions and academic conventions.

# Content

The course treats theories and instruments of management control, including the desired and undesired effects of those instruments, as well as the designs and behavioural effects of management control. Sustainability and gender equality aspects are integrated in the course content, and the course covers management control in both private companies and in the public sector. Instruction is in the form of lectures, group work, oral presentations, and mandatory seminars.

# Examination

Learning outcomes 1-5 are assessed based on a written exam. Learning outcomes 5-7 are assessed based on a written assignment completed in groups and presented and discussed in a seminar.

# Grades

One of the grades Distinction (VG), Pass (G), or Fail (U) is awarded in the examination of the course.
