Course Approval

The syllabus was approved by the Faculty of Arts and Social Sciences 2024-02-22, and is valid from the Autumn semester 2024 at Karlstad University.

Prerequisites

Business Administration 60 ECTS credits, including at least 30 ECTS credits at the G1F level or higher, or equivalent

Learning Outcomes

Upon completion of the course, students should be able to:

- 1. give an account of different management traditions and central management theories,
- 2. define, explain, and discuss key concepts and phenomena in management,
- 3. analyse management in relation to diversity and ethics,
- 4. critically analyse and apply research literature on management,
- 5. search for, collect, evaluate, summarise, and present research sources on management, and
- 6. produce and present texts in accordance with academic standards.

Content

The aim of the course is for students to acquire a broad knowledge of management. The course treats the emergence and later development of management research and focuses on key theories of central aspects of management, such as decision-making, organisation culture, and leadership. Management is seen as a practice carried out by managers as well as employees in an organisation, and as a practice which influences not only the organisation itself, but also other internal and external actors. For this reason, there is a special focus on understanding management in relation to diversity and ethics.

Throughout the course, students learn how to review and use current management research.

Instruction is in the form of oral and written exercises in which theory is applied to practical examples.

Examination

Learning outcomes 1-6 are assessed based on active participation in seminars, oral presentations, and written hand-in assignments, completed both individually and in groups. Learning outcomes 1-4 are also assessed based on a written exam.

Grades

One of the grades Distinction (VG), Pass (G), or Fail (U) is awarded in the examination of the course.

Course evaluation is partly based on student views and experiences obtained in accordance with current regulations and partly on other data and documentation.
