## **Course Approval**

The syllabus was approved by the Faculty of Health, Science and Technology 2020-03-16, and is valid from the Spring semester 2021 at Karlstad University.

## **Prerequisites**

60 ECTS credits in Public Health Science, with 15 ECTS credits in research methods, including Introduction to Qualitative and Quantitative Research Methods (7.5 ECTS credits) and Scientific Research Methods in Public Health Sciences - Literature Study (7.5 ECTS credits), or equivalent

## **Learning Outcomes**

## Knowledge and understanding

- identify and problematise basic theories and research issues in public health science,

## Competence and skills

- independently plan, conduct, and present a research project in public health science,
- search for and select literature relevant to the project,
- collect and analyse data,
- present a research project orally and in writing,

## Judgement and approach

- critically approach other research projects and their own project results, and
- demonstrate awareness of research ethical approaches.

#### Content

Instruction is in the form of literature study, group discussions, mandatory seminars, and supervision.

- Academic thesis
- Research ethics
- Supervision
- Peer review (as reviewer and author)

### **Examination**

Assessment is based on a individual research project presented orally and in writing, and performance as a peer reviewer and seminar participant.

Supervision is provided until the assessment has been made, after which the student is nor longer entitled to further supervision. The number of assessment opportunities is limited to five.

If students have a decision from Karlstad University entitling them to Targeted Study Support due to a documented disability, the examiner has the right to give such students an adapted examination or to examine them in a different manner.

## **Grades**

One of the grades Distinction (VG), Pass (G), or Fail (U) is awarded in the examination of the course.

## **Quality Assurance**

Follow-up relating to learning conditions and goal-fulfilment takes place both during and upon completion of the course in order to ensure continuous improvement. Course evaluation is partly based on student views and experiences obtained in accordance with current regulations and partly on other data and documentation. Students will be informed of the result of the evaluation and of any measures to be taken.
