Knowledge and understanding

Upon completion of the course, students should be able to:

- demonstrate good knowledge of general and specific contract law and damage law,
- demonstrate good knowledge of purchase law pertaining to real and movable estate,
- demonstrate good knowledge of agency law,
- demonstrate good understanding central of property rights principles,
- demonstrate basic knowledge of subcontract law, and
- demonstrate basic knowledge of damage law and insurance law.

Skills and abilities

Upon completion of the course, students should be able to:

- identify and analyse problems related to legal obligations,
- present solutions to contract, purchase and claims problems,
- seek and review material in property rights legal sources,
- identify and solve subcontract problems using standard agreements,
- argue for solutions to legal obligation problems orally and in writing, and
- solve uncomplicated legal claims.

Judgement and approach

Upon completion of the course, students should be able to:

- assess the importance of different sources of law pertaining to legal obligation,

- consider the perspectives of jurisprudence and other sciences on property rights, and
- assess the societal significance of an agreement in terms of economy.

Content

The course offers a thorough study of general and specific contract law, purchase of real and moveable estate and legal claims. Damage claims and insurance law are outlined. Purchase of moveable property is treated from both a commercial and a consumer perspective. In the area of claims the emphasis is on non-negotiable and negotiable instruments of debt. In the area of agency, the focus is on power of authority, commission and commercial agency.

Specific contract law treats standard agreements and subcontracting. Also included is the societal significance of an agreement in terms of economy.
