Course Approval

The syllabus was approved by the Faculty of Health, Science and Technology 2024-05-15, and is valid from the Spring semester 2025 at Karlstad University.

Prerequisites

Swedish nursing licence and at least 60 ECTS credits of further training, or a specialist nursing degree, or admission to the Specialist Nursing programme with a specialisation in public health care, plus upper secondary level Swedish 3 or Swedish as a second language 3 and English 6 or A, or equivalent

Learning Outcomes

Upon completion of the course, students should be able to:

- 1. identify and explain central concepts in pharmacodynamics and pharmacokinetics,
- 2. identify and explain pharmacological interaction and the risks of pharmacological treatment,
- 3. assess the need of aids and prescribe them,
- 4. assess the need of pharmacological and non-pharmacological treatments and prescribe

them.

- 5. give an account of and apply ordinances and other regulations in connection with the prescription of medicinal products,
- 6. give an account of medicinal treatment of patients with different medical conditions in relation to the nurse's rights to prescribe medicinal products,
- 7. plan and conduct instruction to patients on the administration of medicinal products, and
- 8. reflect on age and gender perspectives in relation to medicinal treatment.

Content

This is a course in Medical Science (15 ECTS cr). Instruction is in the form of lectures. The course is a hybrid course (partly net-based, with on-campus meetings) and includes instruction and examination both online and at the university.

The course covers pharmacological concepts, their meaning and importance for the prescription and use of medicinal products. Pharmacological interactions and risks of medicine use are treated, based on FASS and the pharmaceutical handbook.

Pathology, diagnosis, examination, and pharmacological and non-pharmacological treatment are treated in depth in relation to the different areas of the nurse's prescription rights. The nurse's prescription rights and pharmaceutical handling are treated in relation to ordinances and regulations, as well as age and gender aspects of pharmacological treatment.

Students practice assessing the need of medicinal products in terms of assessment support and discuss the advantages and disadvantages of various incontinence products, for example in relation to efficacy, cost, and sustainability. Prescription of pharmaceuticals and medical aids is studied, as well as pedagogy used for instructing patients in connection with prescriptions of medication.

Examination

Assessment is based on an individual written net-based exam, an individual written takehome exam presented and discussed in a seminar, a group exam assessed individually, and roleplay assessed individually.

The examiner may decide that a student who is very close to a passing grade can complete a supplementary assignment to receive a passing grade for a specific examination. Additional examination material must be submitted within six days of notification. The supplementary assignment only is then assessed in accordance with the assessment criteria, and if it is insufficient, a grade of fail (U) will be given.

If students have a decision from Karlstad University entitling them to Targeted Study Support due to a documented disability, the examiner has the right to give such students an adapted examination or to examine them in a different manner.

Grades

One of the grades Distinction (VG), Pass (G), or Fail (U) is awarded in the examination of the course.

Quality Assurance

Follow-up relating to learning conditions and goal-fulfilment takes place both during and

upon completion of the course in order to ensure continuous improvement. Course evaluation is partly based on student views and experiences obtained in accordance with current regulations and partly on other data and documentation. Students will be informed of the result of the evaluation and of any measures to be taken.
