Prerequisites

Registered on the courses KOGV03 Main Instrument II, Western Classical Music (15 ECTS credits), KOGV04 Ensemble II, Western Classical Music (7.5 ECTS credits), and KOGV05 Western Classical Music (7.5 ECTS credits), plus completed the courses Main Instrument I, Western Classical Music (22.5 ECTS credits) and Ensemble I, Western Classical Music (7.5 ECTS credits), or equivalent

Learning Outcomes

Knowledge and understanding

Upon completion of the course, students should be able to:

- 1. give an account of and discuss the tradition of Western classical music from Classicism to Modernism from sociological, cultural and history of ideas perspectives,
- 2. give an account of the harmonics, phrase techniques, style, and form in Western music from Classicism to Modernism,

- 3. give an account of the music repertoire and its performance practices in Western music from Classicism to Modernism,
- 4 give an account of how a practically functioning ear can be used in different musical contexts, and
- 5. give an account of different functions and uses of notation and sequencer software.

Competence and skills

Upon completion of the course, students should be able to:

- 6. arrange music for different instruments and instrument combinations on the basis of the principles of harmonic progression in the Western tradition,
- 7. identify, write down, analyse, and play fairly complicated examples of rhythm, melodics, and harmonics of Western tonal music,
- 8. perform piano-based reduction and harmonic analysis of music from different repertoire areas, and
- 9. apply the basic functions of notation and sequencer software.

Judgement and approach

Upon completion of the course, students should be able to:

- 10. reflect on and discuss their own and others' approach to musical conventions and music notations in relation to the sound of music,
- 11. reflect on the practice, aesthetics, and function of music in a social perspective, and
- 12. give arguments for and assess the importance of linking ear and theory exercises to their own performance in different musical contexts.

Content

The history of Western classical music from Classicism to Modernism is discussed, along with analysis of and exercises in ear training, rhythmics, harmonics, and harmonic progression as well as instrumentation in Western tonal music. Piano-based reduction and harmonic analysis from different repertoire areas are played. The course illustrates and allows students to practice how notation and sequencer software can be applied in different musical and artistic contexts. The practice, aesthetics, and function of music in society are discussed as well as different approaches to music conventions, and the importance of ear training and theory study to musical development.

Instruction is in the form of group sessions and seminars.

Examination
