#### Prerequisites

30 ECTS credits in History of Ideas, Philosophy, Cultural Studies, Political Science, or equivalent, with at 22.5 ECTS credits completed.

#### Learning Outcomes

Upon completion of the course, students should be able to:

##### Knowledge and understanding

- give an account of some of the most important intellectual traditions and the most discussed problems in theory of science and philosophy of science in the past 100 years,
- give an account of some current central politico-philosophical and cultural theoretical approaches,

##### Competence and skills

- identify different interpretative alternatives in reading meta-theoretical texts,
- summarise some main features of meta-theoretical discussions in the past decades and actively participate in current meta-theoretical debates,

##### Judgement and approach

- discuss the social and historical context of meta-theories, and
- critically approach the consequences of meta-theoretical views on the relation between knowledge and culture in terms of power, conflict and representation.

**Content**

The course has a meta-science approach, centring on the theory of science and philosophy of science and philosophy of science from positivism to postpositivism as well as on contemporary cultural theory and political philosophy, studied from the perspective of history of ideas. Students are expected to critically reflect on the theoretical and social basis of science, the relation between knowledge and power, the challenges to contemporary democracy and different views of the general conditions and crises of Western culture.

Instruction is in the form of lectures, presenting essential content, and mandatory seminars on course content in the light of course literature, in which students discuss their understanding orally and in writing.

**Examination**

Assessment is based on a take-home exam and active participation in seminars at which written individual hand-in assignments are regularly discussed.

**Grades**

One of the grades Distinction (VG), Pass (G), or Fail (U) is awarded in the examination of the course.
