The syllabus was approved by the Board of Teacher Education 2019-02-11, and is valid from the Autumn semester 2019 at Karlstad University.

Prerequisites

Admitted to pedagogical bridging programme after third-cycle qualification, LPGKF8 completed, and enrolled in LPGK10 and LPGK11.

Learning Outcomes

The aim of the course is that students develop knowledge and understanding of how teachers can plan their teaching and use assessment as a basis for developing pupils' learning. They take into account subject-specific education perspectives on teaching and learning, with a focus on one or two specific subjects and a general perspective on several subjects.

Upon completion of the course, students should be able to:

1. Plan and problematise teaching in their chosen subjects on the basis of a subject-specific education perspective,

- 2. Discuss and analyse how formative and summative assessment can promote pupils' learning in their chosen subjects.
- 3. Critically examine different types of assessment materials in their chosen subjects in terms of pedagogical and subject-specific teaching models/theories/perpectives.

Content

The course covers the following:

- how different types of teaching in the given combination of subjects relate to steering documents and research on subject-specific education
- the implications of a science and/or mathematics approach, and conditions for subject integrated teaching
- factors that impact pupils' attitudes, interest, and motivation in relation to the combination of subjects
- practical examples of assessment and grading, including various types of national assessment guides, such as the test bank provided by the Agency of Education and the national tests
- current subject-specific education research on assessment and evaluation

The course includes varied forms of work and the students take active part in, for instance, group conversations and seminars.

One of the grades Distinction (VG), Pass (G), or Fail (U) is awarded in the examination of the course.
