#### Course Approval

The syllabus was approved by the Board of Teacher Education 2025-02-12, and is valid from the Autumn semester 2025 at Karlstad University.

#### Prerequisites

Completed Music and Music Teaching 8, 7.5 ECTS credits, Teachers' professional leadership 2 - music teachers, 7.5 ECTS credits, and Teacher Training Practice 3 - Music Education, 7.5 ECTS credits, plus Instrument and Ensemble 6, 7.5 ECTS credits, or Classroom Music Teaching 6, 7.5 ECTS credits, or Music Theory and Composition 6, 7.5 ECTS credits, or Music and Sound Production 6, 7.5 ECTS credits, and registered for Music and Music Teaching 9, 7.5 ECTS credits, plus Instrument and Ensemble 7, 7.5 ECTS credits, or Classroom Music Teaching 7, 7.5 ECTS credits, or Music Theory and Composition 7, 7.5 ECTS credits, or Music and Sound Production 7, 7.5 ECTS credits, or equivalent

#### Learning Outcomes

The aim of the course is for students to develop advanced craftsmanship and artistic skills, as well as an analytical educational approach to musical learning and interpretation.

Module 1: Instrument, 5.5 ECTS cr.

Upon completion of this module, students should be able to:

1. compare, discuss, and interpret various musical expressions and interpretations,
2. independently solve performance challenges and shape selected repertoire based on their own musical ideas, and
3. identify their artistic and technical development needs and take responsibility for their own progress.

Module 2: Music education, 2 ECTS cr.

1. give an account of and reflect upon advanced methodological aspects of teaching the main instrument at intermediate and/or higher levels, based on the chosen approach for their instrument, and
2. identify the need for further instrumental methodological knowledge and competence based on reflections on independently conducted teaching practice.

### **Content**

The course comprises two modules.

#### **Module 1**

The module includes performance of music on the main instrument through instrumental lessons and independently planned and conducted skills training.

#### **Module 2**

This module covers instrumental methodology, addressing advanced methodological aspects based on the chosen approach for each main instrument, instrumental methodology seminars with selected themes, and execution of and reflection upon supervised teaching practice on the main instrument within compulsory or elective school activities.

### **Examination**

#### **Module 1**

Learning outcomes 1 and 2 are assessed individually based on practical musical performance and oral presentations.

Learning outcome 3 is assessed based on an individual oral or written assignment.

#### **Module 2**

Learning outcomes 1 and 2 are assessed based on oral group presentations, individual written hand-in assignments, and teaching practice.

Submissions for assessment must clearly indicate individual contributions.

If students have a decision from Karlstad University entitling them to Targeted Study Support due to a documented disability, the examiner has the right to give such students an adapted examination or to examine them in a different manner.

### **Grades**

One of the grades Pass (G) or Fail (U) is awarded in the examination of the course (RB 129/22 Dnr C2022/895).

### **Quality Assurance**

Follow-up relating to learning conditions and goal-fulfilment takes place both during and upon completion of the course in order to ensure continuous improvement. Course

evaluation is partly based on student views and experiences obtained in accordance with current regulations and partly on other data and documentation. Students will be informed of the result of the evaluation and of any measures to be taken.
