Course Approval

The syllabus was approved by the Board of Teacher Education 2025-02-12, and is valid from the Autumn semester 2025 at Karlstad University.

Prerequisites

Completed Music and Music Teaching 3, 15 ECTS credits, and Teachers' pedagogical approach 1 - Music teachers, 7.5 ECTS credits, and registered for Music and Music Teaching 4, 7.5 ECTS credits, and Teachers' pedagogical approach 2 - Music teachers, 7.5 ECTS credits, or equivalent

Learning Outcomes

The aim of the course is for students to acquire an in-depth ability to interpret music on their main instrument, from an artistic perspective, and broaden their instrumental or vocal knowledge and skills across various musical genres to achieve strong subject competence for their future professional role.

Upon completion of the course, students should be able to:

1. musically interpret repertoire from various musical styles,
2. demonstrate an alternative approach in relation to the genre of their main instrument, and

3. identify and practically solve musical challenges in ensemble playing.

Content

The course includes instrumental or vocal skills training and musical interpretation on the main instrument through instrumental lessons and ensemble playing. The course also includes broader musical approaches in the form of improvisation, playing by ear, and performing music from notation. Students study one of these approaches as a complement to the genre of their main instrument.

Broadening of musical approaches for students with a main instrument in:

- folk music involves improvisation and performing music from notation.
- classical music involves improvisation and playing by ear.
- rhythmic and improvised music involves playing by ear and performing music from notation.

Examination

Learning outcomes 1-2 are assessed based on musical performance, completed individually and in groups.

Learning outcome 2 is also assessed based on an individual written assignment on improvisation.

Learning outcome 3 is assessed orally and practically based on a group musical performance.

Submissions for assessment must clearly indicate individual contributions.

The number of assessment opportunities is limited to five.

If students have a decision from Karlstad University entitling them to Targeted Study Support due to a documented disability, the examiner has the right to give such students an adapted examination or to examine them in a different manner.

Grades

One of the grades Pass (G) or Fail (U) is awarded in the examination of the course (Dnr 2020/991).

Quality Assurance

Follow-up relating to learning conditions and goal-fulfilment takes place both during and upon completion of the course in order to ensure continuous improvement. Course evaluation is partly based on student views and experiences obtained in accordance with current regulations and partly on other data and documentation. Students will be informed of the result of the evaluation and of any measures to be taken.

A course certificate will be provided upon request.
