Learning Outcomes

Upon completion of the course, the students should be able to:

- -describe and define Geographical Information Systems (GIS) and give examples of how they can be utilized,
- -use and process geographic data in various formats,
- -describe the differences between vector and raster data,
- -assess and compare various geographic internet-based systems, and
- -carry out simple geographic analyses in vector data.

Content

The course is primarily designed for students who want to learn different ways of using GIS technology and to students seeking a general understanding of GIS in order to collaborate more effectively with experts in the field.

The course covers central concepts and definitions. Students are given a number of reading and literature assignments. The course includes an introduction to commonly used GIS software, including introductory exercises as well as more advanced exercises designed to help students learn a particular software programme, deepen their knowledge, and apply their knowledge in practice. Students are also introduced to ongoing processes of development and standardization in the field. Finally, students undertake a project in which they apply the theoretical knowledge that they have acquired.

Examination

Examination is in the form of individual hand-in assignments and a written individual project that can be presented and discussed in a seminar. In the seminar or at another occasion, students are required to prove their identity.

Grades

One of the grades Pass with Distinction (VG), Pass (G), or Fail (U) is awrded in the examination of the course.

Course evaluation is partly based on student views and experiences obtained in accordance with current regulations and partly on other data and documentation.
