### Course Approval

The syllabus was approved by the Faculty of Health, Science and Technology 2025-08-29, and is valid from the Spring semester 2026 at Karlstad University.

### Prerequisites

120 ECTS credits completed in the Dental Hygiene Programme, semesters 1-4, and registered for the courses Oral health prevention and treatment for different ages - Clinical studies III, 15 ECTS credits, and Ageing in theory and practice and with a focus on oral health, 15 ECTS credits

### Learning Outcomes

Upon completion of the course, students should be able to:

Knowledge and understanding

- give an account of oral health from social, socioeconomic, and gender equality perspectives, nationally and internationally,
- give an account of organisation and leadership in dentistry and the current and future role of the dental hygienist in the organisation,

- give an account of the significance of national and international policy documents for public health and their implications for dentistry,
- analyse the determining factors of oral health based on current research and in relation to the health promotion work carried out by the dental hygienist.

#### Competence and skills

- independently demonstrate suggestions for the implementation and evaluation of oral health promotion based on an international sustainability goal.

#### Judgement and approach

- independently consider ethical aspects with a holistic view of human beings and a special focus on human rights when planning health promotion efforts, and
- reflect upon and make comparisons in the field of oral health nationally and internationally in relation to sustainable development.

### **Examination**
