#### **Examination**

Assessment is based on:

- an independent written degree project
- an individual oral presentation
- a final seminar with peer review

The number of assessment opportunities is limited to five. Submissions for assessment must clearly indicate individual contributions. Attendance is mandatory, and active participation in supervision sessions and seminars is required for a passing grade.

If students have a decision from Karlstad University entitling them to Targeted Study Support due to a documented disability, the examiner has the right to give such students an adapted examination or to examine them in a different manner.

#### Grades

One of the grades Distinction (VG), Pass (G), or Fail (U) is awarded in the examination of the course.

#### **Quality Assurance**
