Upon completion of the course, students should be able to:

Knowledge and understanding

- give an account of oral health from societal, socioeconomic, and gender equality perspectives, nationally as well as internationally,
- give an account of organisation and leadership in dentistry and the current and future role of the dental hygienist within the organisation,
- give an account of the significance of national and international public health policy documents and their implications for dentistry, and
- analyse the determinants of oral health based on current research and in relation to the

health promotion work of the dental hygienist.

Competence and skills

- independently demonstrate suggestions for implementing and evaluating oral health promotion efforts based on an international sustainability objective.

Judgement and approach

- independently assess ethical aspects with a holistic view of human beings and a special focus on human rights when planning health promotion work, and

Examination
